"BOSCH Q4 2024 NZ" PROMOTION

TERMS AND CONDITIONS

- 1. Instructions on how to claim and the gifts form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer.
- 2. The promoter is Robert Bosch (Australia) Proprietary Limited (ABN 48 004 315 628) of 1555 Centre Road, Clayton, VIC 3168, Australia, telephone 1300 30 70 37 ("**Promoter**").
- 3. Claims are only open to New Zealand residents aged 18 years or over.
- 4. Employees (and their immediate families) of the Promoter, Participating Stores (as defined below) and agencies associated with this promotion are ineligible to claim. - 10. Gifts will be delivered to the residential address of the claimant as specified on the claim form. Delivery of the gift can take up to eight (8) weeks from the date a claim is verified and approved as valid. - 26. The Promoter and its officers, employees, related bodies corporate and agents will not be responsible for any incorrect, inaccurate or incomplete information received or not received in the course of or in connection with this promotion if the deficiency is occasioned by any cause outside the Promoter's reasonable control including but not limited to technical malfunctions or failures.
- 27. All claims become the property of the Promoter. The Promoter collects personal information about claimants to enable claimants to participate in this promotion.
